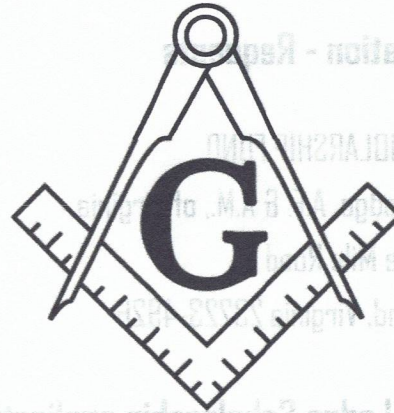


GRAND LODGE SCHOLARSHIP PROGRAM

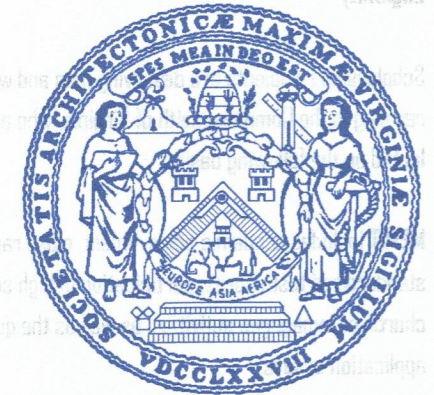

The Scholarship Fund Grand Lodge, A.F. & A.M., of Virginia

The program's purpose is to provide scholarships, fellowships and other forms of financial assistance to deserving men and women from the Commonwealth of Virginia.



Eligibility

Scholarship recipients are deserving men and women, residing in the Commonwealth of Virginia, who are selected on the following basis:

MERIT includes academic achievement, class rank, standardized test scores, participation in high school, church or synagogue activities, as well as the quality of application essays.

NEED is determined by the applicant's financial status. The financial evaluation will include a review of the family's adjusted gross income, checking and savings accounts, stocks and securities, equity in land and real estate holdings, etc. This evaluation helps to determine the applicant's ability to obtain assistance from financial institutions.

Financial Aid Form

The Financial Aid Form is required and should be forwarded to the Grand Lodge of Virginia as soon as possible. The Financial Aid Form may be obtained from the high school counselor or from the college or university, which the student expects to attend.

Award

The members of the Board of Directors review applications and award scholarships up to \$1,000 each. These are renewable for four years depending upon the availability of funds and satisfactory academic performance and continuing need.

Notification Of Decision

All applicants who submit *completed applications and all supporting documents* will be notified of the Board's decision by mail.
