 - C. Deadline for all ads is March 15, 2026.

Instructions for Submitting Ads

- Inside Ads must be black and white (Grayscale)
- Electronic Ads are preferred and may be emailed to Lynn Wagner at waglyn@cox.net. Be sure that the ad is a .pdf or .jpg. Also be sure to mail a paper copy of the ad, the ad form and payment via regular postal mail with a note that the electronic copy has been sent. Ads will not be printed unless payment is received.
- If the ad is only submitted by mail, please **do not** fold the ad as a crease will detract from the appearance of your ad. These ads must be copied to process them so, please do not send ads with black(Dark) backgrounds or colored special logos. They do not copy well.
- The Ad text <u>must</u> fit in the size on the Example page for the ad you have chosen. Note that Full page means 5" x 7.5" and **NOT** 8.5" x 11", with sufficient margin around the outer edges.
- An individual order form <u>must</u> be submitted for each ad. Make copies beforehand, contact Lynn Wagner, or find it on the Grand Chapter website at <u>www.easternstar-virginia.org</u> under Forms.
- Your ads are important. They share your fraternal friendship and respect, who and what is important to you, as well as businesses that are of interest to all of us, so submit your ads early!
